

The Olmsted Township Zoning Commission meeting of June 14, 2000 was called to order at 7:30 p.m. Present were Vice Chairman Al Arlow, Ryan Thomas, Rick Witherspoon and Ron Campanalie. Also, present was secretary Tammy Tabor. The secretary read the minutes from the special meeting of April 24, 2000. Mr. Thomas moved to approve with the following correction: omit "Mr. Bajorek" on the third line. Mr. Campanalie seconded Mr. Thomas' motion. Roll call. Mr. Thomas-yes, Mr. Campanalie-yes, Mr. Witherspoon.-yes, Mr. Arlow -abstain. The secretary read the minutes of the Zoning Commission meeting of May 10, 2000. Mr. Campanalie moved to approve the minutes as read. Seconded by Mr. Thomas. Roll call, Mr. Thomas -abstain, Mr. Witherspoon - yes, Mr. Campanalie - yes, Mr. Arlow - yes.

Resolution C-00

Mr. Arlow asked Mr. Fred Shaker if he had any additional information on his application for rezoning. Mr. Shaker stated that he is requesting a parcel of property to be rezoned from R1-40 to RMFT. The parcel has a gas well on the lot and it will be capped later this year. Mr. Thomas moved to set the public hearing for July 12, 2000 at 8:00 p.m. at the Township Hall. Seconded by Mr. Campanalie. Roll call, all approved.

Resolution B-00

Mr. Witherspoon moved to table the regular meeting and open the public hearing for Resolution B-00. Seconded by Mr. Thomas. Roll call. All approved. Mr. Arlow asked Mr. Madow, representing Falls Pointe, to come forward. Mr. Arlow stated that the County had not forwarded recommendations to the Zoning Commission. Mr. Madow stated that he spoke with Mr. Tom Schultz of the Cuyahoga County Planning Commission and Mr. Schultz stated that the recommendation would be for approval of Resolution B-00. Mr. Arlow stated that the Olmsted Township Commission could make a recommendation contingent on the receipt of recommendations from the County Planning Commission. Mr. Thomas moved to approve Resolution B-00 upon receiving recommendations from the County Planning Commission. Seconded by Mr. Witherspoon. Roll call, All approved.

Mr. Thomas moved to close the public hearing for Resolution B-00 and re-open the public hearing for Resolution G-99. Seconded by Mr. Campanalie. Roll call. All approved.

Mr. Thomas moved to table the public hearing on Resolution G-99 until the July 12, 2000 meeting. Seconded by Mr. Campanalie. Roll call , all approved.

Mr. Campanalie moved to reopen the regular meeting. Seconded by Mr. Witherspoon. Mr. Campanalie moved to adjourn. Seconded by Mr. Thomas. Roll call, all approved.
