WHEREAS, the Board of Trustees of Olmsted Township has created and established a Zoning Board; and

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of Olmsted Township, State of Ohio, that David Romaine is hereby appointed to continue on the Zoning Board for a 4-year term beginning August 1, 2008.

Be It Resolved by the Township Trustees of Olmsted Township that

A RESOLUTION TO ADDRESS THE ABATEMENT OF NUISANCES WHERE THE OWNERS OF PROPERTY HAVE FAILED TO PROPERLY MAINTAIN GRASS, WEEDS, VEGETATION, REFUSE, AND DEBRIS

WHEREAS, the Board of Trustees has authority under O.R.C. 505.87 to abate nuisances; and

WHEREAS, the condition of certain properties constitute a nuisance when the owners of those properties have failed to maintain their property in accordance with the Olmsted Township Property Maintenance Code; and

WHEREAS, the property at 26293 Kingswood Drive, also known as PPN 263-10-058, has not complied with violation notices and requests to maintain the property.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of Olmsted Township, State of Ohio, that:

SECTION 1: The Board of Trustees hereby determines the condition of the property located at 26293 Kingswood Drive, also known as PPN 263-10-058, constitutes a nuisance because the owner and/or lien-holder of this property has failed to maintain the grass, weeds, refuse and/or other debris on said property in accordance with the Olmsted Township Property Maintenance Code.

SECTION 2: The Building Commissioner is hereby authorized and directed to provide the notice called for in O.R. C. 505.87(B) to order the owner(s) to abate the nuisance. If such nuisance is not abated within the prescribed time limitations, the Building Commissioner shall take any and all steps necessary to rectify said nuisance and maintain the prescribed parcel as required to meet continued compliance. All costs incurred by Olmsted Township regarding this action shall be forwarded to the Cuyahoga County Auditor for recovery.

SECTION 3: It is hereby found and determined that all formal actions of this Board of Township Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.




