## **DEPARTMENT UPDATES**

- 1. Dept of Public Service hydrants are active for emergency purposes on Barrett; due to decent weather, Barrett road improvements remain active re: maintenance/culverts; water main break on Fitch Road at Adele county fixed the issue in short time; county will perform roadway repairs; Columbia road ODOT to complete pavement evening this spring; There has been discussion that Cleveland Water to put up a water tower? Next 5-year financial plan does not include this project.
- 2. Police Dept no update
- 3. Fire Dept beginning process of meeting with representatives for Relay For Life (logistic) and will also be meeting with the Board; reviewing fire suppression system for Vitamix; Barrett Road water line is operational which will help FD more directly regarding their ability to tap into hydrants in the vicinity; in house vehicle maintenance has resulted in cost savings of approx \$2,500 in labor costs, all in an effort to keep the fleet up to par.
