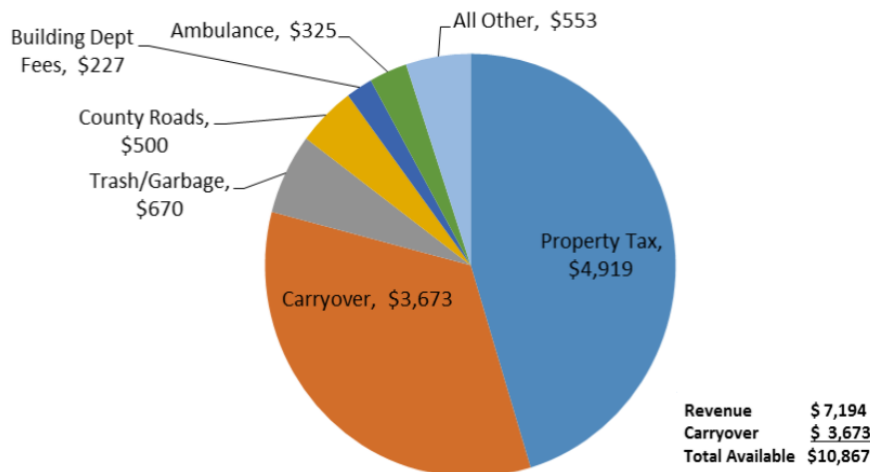

Where our tax dollars come from...

2017 Anticipated Revenue (,000's) (including Carryover)



Olmsted Township receives 18¢ of every property tax dollar. Olmsted Falls Schools receive 55¢ and 27¢ is disbursed to Cuyahoga County, Library, MetroParks, and JVS (Polaris.)

Carryover — set aside from prior years and earmarked specifically for Township infrastructure improvements, including road repair/maintenance, stormwater issues, sidewalks, economic development and the completion of the Service Department Complex.

County Roads—received from Cuyahoga County and must be used only to maintain County roads in Olmsted Township.

Ordinary townships in Ohio are not permitted to collect an income tax. If you LIVE & WORK in Olmsted Township, you pay ZERO income tax. If you LIVE in Olmsted Township but WORK in another city, you pay income tax based on that city's tax rate.

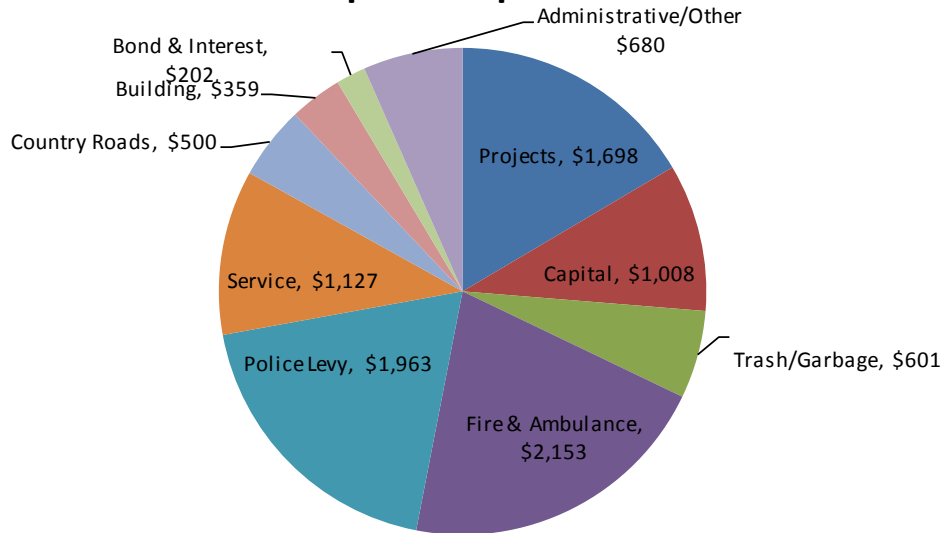

2017 Anticipated Expenditures (,000's)



Projects & Capital — The Trustees, Fiscal Officer and leadership Team have taken the past year to plan and prepare for capital expenses, including replacement of vehicles, equipment and facility improvement. Projects will include the infrastructure noted on the revenue side. 2017 will see the implementation of the plans and projects.

Police, Fire, Service — Each department operates within established budget parameters; all operating expenses...salaries/benefits, training, equipment, facility maintenance and some capital expenditures are included in each budget.

Police and Fire Departments are funded through designated levies. Monies from these continuing levies can only be used for the operation of these departments. Ambulance money is also designated and can only be used by the fire department.

The Police Department budget is supplemented by the General Fund to ensure budget stability and integrity.

The Service Department budget includes approximately \$115,000 in salt used during snow & ice season.

Administrative Costs—This represents the cost of government including accounting & legal fees, professional & technical services, insurances, contracted services, salaries/benefits for elected officials and support staff.
