RESOLUTION OF THE BOARD OF TOWNSHIP TRUSTEES OF OLMSTED TOWNSHIP, OHIO

following Resolution:			

WHEREAS, Olmsted Township has in place a Zoning Resolution as authorized under R.C. 519.02, *et seq.*; and

WHEREAS, provisions of the Zoning Resolution provide for various standards pertaining to landscaping and architectural elements for land and structures located within the unincorporated area of the township; and

WHEREAS, the Board of Trustees desires to provide for the enforcement of compliance with such standards in an orderly manner.

NOW THEREFORE, it is hereby RESOLVED by the Trustees that:

Pursuant to Ohio Revised Code Section 505.171, in lieu of an architectural review board, the authority for enforcement of compliance with the landscaping and architectural standards contained in the Zoning Resolution of Olmsted Township is hereby delegated to the Township Zoning Commission.

The landscaping and architectural standards set forth in the Zoning Resolution of Olmsted Township shall, consistent with the Zoning Resolution, apply to all new construction, modifications and other projects to which the Zoning Resolution otherwise applies. The procedures to be used by the Zoning Commission in the enforcement of the landscaping and architectural standards shall conform to those already established in the Zoning Resolution for the submission of applications, and as provided for in R.C. 519.04.

Each application for a zoning permit, exclusive of applications for the construction or modification of single family residences, shall include, or be accompanied by, a landscape plan and design plan or drawings sufficient to demonstrate compliance with the landscaping and architectural standards of the Zoning Resolution. Review of such plans for compliance shall be directed to the Zoning Commission and conducted during a meeting of the Zoning Commission scheduled and held in compliance with all applicable notice rules and regulations.

Trustee seconded the motion and, thereupon, the votes in favor of the Resolution were recorded and are reflected by the signatures hereto.
