Retaining Fabrizi Trucking and Paving Company, Inc. – Wheel Loader Rental
Cuyahoga County, Ohio

Be it Resolved by the Township Trustees of Olmsted Township, that

WHEREAS, the Olmsted Township Board of Trustees deems it necessary to retain the professional services of Fabrizi Trucking and Paving Company, Inc. to support the snow and ice removal activities as defined in the proposal dated October 2017.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Olmsted Township, Cuyahoga County, State of Ohio, that:

Fabrizi Trucking and Paving shall be retained to provide rental of a wheel loader at a cost not to exceed \$9,600 (\$2,400 per month) beginning January 1, 2018 and extend through April 30, 2018.

BE IT FURTHER RESOLVED; that it is hereby found and determined that all formal actions of this Board of Township Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action, were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

WHEREAS, Contractor agrees to provide the following equipment to Olmsted Township at the rate listed;






