

# RESOLUTION 079-2018

*Necessity for Replacement of Tax Levy*

## RESOLUTION OF THE BOARD OF TRUSTEES OF OLMSTED TOWNSHIP, CUYAHOGA COUNTY, OHIO

Resolution requesting the Cuyahoga County Fiscal Officer to certify the total current tax valuation of property within Olmsted Township and the amount to be generated from a replacement tax levy.

This date, June 27,, 2018, Trustee Zver,

moved the adoption of the following Resolution:

WHEREAS, the Olmsted Township, Cuyahoga County, Ohio Board of Trustees is a taxing authority empowered to submit a tax levy on its behalf, and for Olmsted Township, within the meaning of Ohio Revised Code Section 5705.01; and

WHEREAS, Ohio Revised Code Section 5705.19(A) authorizes the Board of Trustees of any township to request that the question of a tax levy be submitted by the taxing authority to the electors of the subdivision; and

WHEREAS, the Board of Trustees has determined the necessity for a replacement of a tax levy to sustain the operations of the Township, pursuant to R.C. 5705.19(A); and

WHEREAS, this Board intends to place the question of a four (4.00) mills replacement levy on the November 6, 2018, General Election ballot, for current expenses of Olmsted Township as expressed in R.C. 5705.19(A), for a period of five (5) years; and

WHEREAS, Ohio Revised Code Section 5705.03, requires this Board to request certification of the total current tax valuation of the Township and the total amount of revenue that would be generated by the requested levy.

**NOW THEREFORE**, it is hereby RESOLVED by the Board of Trustees that:

1. The Board intends to initiate proceedings for the submission to the electors of Olmsted Township (located in Cuyahoga County, Ohio), at the General Election to be held November 6, 2018, the question of a replacement tax levy for current expenses of the Township, pursuant to R.C. 5705.19(A), for a period of five (5) years.

2. It is necessary to assess a tax, for a period of five (5) years, for operation of the Township, namely:

A replacement of a tax for the benefit of the Township of Olmsted for the purpose of current expenses at a rate not exceeding four (4.00) mills for each one dollar of valuation, which amounts to forty cents (\$0.40) for each one hundred dollars of valuation, for five (5) years, commencing in 2019, first due in calendar year 2020.


3. The Cuyahoga County Fiscal Officer is hereby requested to certify the current tax valuation of Olmsted Township and total dollar amount of revenue that would be generated by a four (4.00) mills replacement levy, to run for a five (5) year period commencing with tax year 2019, for the benefit of the Township.

4. The Fiscal Officer is directed to deliver a certified copy of this Resolution to the Cuyahoga County Fiscal Officer.


Trustee Kress seconded the motion and, thereupon, a roll call vote was taken and the results were recorded and are reflected herein below.
