**WHEREAS**, the Office of Fiscal Officer of Cuyahoga County continues to oversee the funding sources and balance of Olmsted Township funds.

**WHEREAS**, Olmsted Township has determined the projected funding sources for 2018 based on historical data, information received by the County Fiscal Office regarding projected real property revenues and current year funding sources.

**WHEREAS**, the Board of Trustees of Olmsted Township authorize the Fiscal Officer of Olmsted Township to submit a copy of an Amended Certificate of Estimated Resources for 2018 to the Office of the Fiscal Officer of Cuyahoga County for certification, which is a requirement under state law.

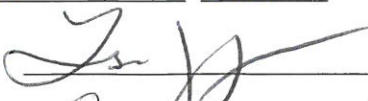
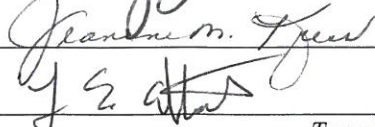
