

RESOLUTION NO. 183-2018

Adoption of 2017 Fire Codes

Cuyahoga County, Ohio

Be it Resolved by the Township Trustees of Olmsted Township, that

WHEREAS, Ohio Revised Code 505.373 permits a Board of Township Trustees by resolution to adopt by incorporation by reference a standard code pertaining to fire, fire hazards, and fire prevention prepared and promulgated by among others, the state or a private organization that publishes a model or standard code; and

WHEREAS, the Board of Township Trustees Olmsted Township desires to adopt by incorporation by reference the Ohio Fire Code to which the Township adheres to; and

WHEREAS, the Board finds it to be in the best interest of the residents of Olmsted Township to adopt the standard code of application with the Township.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of Olmsted Township, State of Ohio, that;

Section 1: The 2107 Ohio Fire Code, as published by the International Code Council, and as the same be amended from time to time, is hereby adopted by the Board and incorporated by reference.

Section 2: The Fiscal Officer for Olmsted Township is hereby directed to publish a notice clearly identifying the 2017 Ohio Fire Code, stating the purpose is on file with the Fiscal Officer for inspection by the public and also on file at "The Ohio Law Writer". The Fiscal Officer shall post such notice in five conspicuous places in the Township for thirty days before this resolution becomes effective, as required by law.

Section 3: In the accordance with the Ohio Revised Code Section 505.374, no person shall violate a provision of the 2017 Ohio Fire Code as adopted or amended by the Board, and each day of continued violation of the 2017 Ohio fire Code shall constitute a separate minor misdemeanor for which penalty shall be imposed pursuant to the Ohio Revised Code Section 505.99.

Section 4: Upon majority vote does hereby dispense with he requirement that this Resolution be read on two separate days and hereby authorizes the adoption of this Resolution upon its first reading.

BE IT FURTHER RESOLVED; that it is hereby found and determined that all formal actions of this Board of Township Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action, were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
