Be it Resolved by the Township Trustees of Olmsted Township, that



WHEREAS, Olmsted Township Board of Trustees in their committed efforts to ensure the quality of life for the residents in Olmsted Township and to be responsible for best practice management of our stormwater efforts is hereby instituting a leaf collection program for the community of Olmsted and is partnering with THREE-Z-INC. to provide leaf collection for the residents of Olmsted Township.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of Olmsted Township, Cuyahoga County, State of Ohio, that: the Board of Trustees is entering into a vendor agreement with THREE-Z-INC. to provide Leaf Collection Services for the 2018 and 2019 Fall Leaf Collection Season for the benefit of the residents and community of Olmsted Township. (Marked Exhibit A and attached hereto and made a part hereof as though fully rewritten here.)

BE IT FURTHER RESOLVED; that it is hereby found and determined that all formal actions of this Board of Township Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action, were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**LEAF COLLECTION AND DISPOSAL CONTRACT
ADDENDUM FOR OPTIONAL YEAR(S)**

This addendum pertains to Olmsted Township Resolution Number 155-2015 and the Leaf Collection and Disposal Contract between the Township Trustees of Olmsted Township and Three-Z-Inc. dated October 14, 2015.

Per the Articles of Agreement and in acknowledgment that the First (2015), Second (2016) and Third (2017) Contract Years have been successfully completed in accordance with the Leaf Collection and Disposal Contract, the Township Trustees of Olmsted Township agree to exercise their option for a Fourth (2018) and Fifth (2019) Contract years. Three-Z-Inc agrees to provide leaf collection and disposal services for Option Year 4 (2018) for the sum of \$58,897.00 and Option Year 5 (2019) for the sum of \$58,897.00. The total 2 year sum is \$117,794.


All other obligations, terms and conditions of the October 14, 2015 Leaf Collection and Disposal Contract remain in effect for the duration of this Addendum.


