Acceptance of Submission of FY -2018 Community Development Block Grant Program Application
Cuyahoga County, Department of Development

Cuyahoga County, Ohio

Be It Resolved by the Olmsted Township Board of Trustees that:

WHEREAS, Olmsted Township was eligible to apply for Community Development Block Grant funds (CDBG) administered by the Cuyahoga County Department of Development to assist municipalities with a variety of projects addressing, housing, economic development and community improvement projects, including community master plans, housing and commercial demolition, infrastructure, public safety, streetscapes, parks playgrounds, community and senior centers and ADA improvements.

WHEREAS, On July 10, 2018, Cuyahoga County Council approved Olmsted Township's application for the **TOWNSHIP WIDE- ADA CURB RAMP PROJECT** utilizing CDBG funds for \$150,000.

WHEREAS, the location is throughout the township in various locations within two subdivisions known as, the Villages and Breezewood.

WHEREAS, Olmsted Township will continue to implement its Transportation for Livable Communities Plan and has a Complete Streets Plan completed in August 2015. This plan addresses sidewalk coverage and safe connections throughout the township with an analysis of roughly 900,000 square feet of missing sidewalks throughout the township. Currently, prohibiting connectively and safe passages for pedestrians. and will continue to follow this plan and match funding sources where applicable.

WHEREAS, as part of Olmsted Townships Comprehensive Plan update, May 2018, residents have responded to a community wide survey indicating Bicycle and Pedestrian Paths being the number one needed item under Community Facilities. To date, the township has received over 500 survey responses.

WHEREAS, investing in Olmsted Township's ability to maintain its infrastructure has benefits to Cuyahoga County as preserving, maintaining, and investing in infrastructure will help the region in sustaining positive economic and community development efforts, and as such, will also promote the health and welfare of Olmsted Township and its residents.



NOW THEREFORE IT BE RESOLVED: that the Board of Trustees of Olmsted Township accepts the award from Cuyahoga County Council and the County Executive recommendations of the award of \$150,000. And authorizes the Township Administrator to implement the **TOWNSHIP WIDE- ADA CURB RAMP PROJECT** utilizing CDBG funds application for \$150,000.
