Be it Resolved by the Township Trustees of Olmsted Township, that

WHEREAS, a need exists within the Olmsted Township Fire Department to hire a part-time firefighter/ paramedic, and to establish the working conditions of the part-time firefighter/ paramedic;

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of Olmsted Township, State of Ohio, that:

Ammar Dardari is appointed to the position of part-time firefighter/ paramedic within the Olmsted Township Fire Department, and to satisfy the firefighter/ paramedic requirements of the position as a condition of employment. This appointment shall take starting on or after Monday, October 29, 2019 upon successful completion of criminal background check, pre-employment drug and alcohol test/screen, and pre-employment physical.

FURTHERMORE, BE IT RESOLVED that:

1. Ammar Dardari shall serve a twelve (12) month probationary period.
2. Ammar Dardari shall not scheduled to work an hours in excess of 1,560 hours annually.
3. Ammar Dardari shall serve at the Pleasure of the Board of Trustees, and shall not be entitled to any fringe benefits (medical, dental, etc.).
4. Ammar Dardari will receive the hourly rate \$16.50; shall be raised to \$17.50 after successful completion of initial training and placed on the duty schedule.
